Charles Hassler, Salem -

- Stated concerns about the 4:00pm Freeholder meetings and asked the board to reconsider changing back to 7:00pm meeting for everyone to attend.
- Identified an agenda typo which should read that the next meeting is February 15<sup>th</sup>.

Director Vanderslice stated that the 3<sup>rd</sup> week meetings of the month will still begin at 7:00pm, but there were concerns raised with public wanting to attend meetings, but unable to drive in the dark. We are trying to accommodate everyone.

Patty Bomba, Carneys Point -

- Thanked Freeholder DeCastro for looking into the matter of the typo.
- Stated that she hopes to see some transparency soon between the parties.

Carolyn Shoemaker, Vice President of CWA 1085 -

- Stated concerns of little progress regarding today's meeting with the Union and mediator.
- The union has been more than willing to negotiate but nothing is being accomplished.
- There are upset employees, staff replacements not being made causing double duties, morale is low, and hopes a whole "picture solution" can be made.

#### Joe Hiles. Woodstown -

- Stated his concerns as chief shop steward and disheartening feel from today's meeting with the CWA.
- Has been very hopeful in this being a new year, with a new director, with a hopeful message at the Reorganization meeting and county employee meeting.
- This message is hard to believe when the Freeholder administration does not sit at the table.
- Wants to restore faith, morale, and what is overall best for Salem County and its residents.

#### Michael Stites, Ouinton -

- Stated as a 21 year employee he was very disheartened to have accomplished nothing from the CWA negotiations with a mediator. It was a wasted day off.
- A resolution of the negotiations needs to be done as there has been no change since October 2016.
- Would like to see a fair and honest contract.

## Jolyn Mitchell, Quinton -

- Stated how, after facing 11 years of possibly being laid off, she now has to work two jobs to keep her employment, Public Works and Mosquito Commission.
- Mentioned that not one Freeholder showed up today for the CWA negotiation meeting.
- She, along with the rest of members, just want to be heard and feels like no one cares what they are concerned about, or have interest in what they have to say.
- Stated everyone appreciates what the Board does, but asks for them to please take an interest in coming up with a resolution for a fair, honest and reasonable contract.

#### Denise DiTeodoro, Mannington -

- Stated she was not born or raised in Salem County, but chose Salem County. Chose to live here and chose to raise her family here.
- She has 2 degrees, but loves her job and is passionate about it.
- Stated that statistics show dispatchers are amongst the top 12 job titles that commit suicide.
- Stated that she has been employed with the County and has more experience than anyone sitting on the Freeholder Board.
- Stated there is a rumor out there, and everyone is concerned for their jobs again, and please ask the Freeholder Board to be honest, and not put their department through what happened last year.
- She is a small business owner and understands the struggle of balancing a budget and taxes.
- She reiterated that she chose this county and chooses to represent Salem County.
- She thanked everyone on the Freeholder Board for their hard work and service.

#### Gerald Baber, Alloway -

- Stated that 9 days ago there was a great County employee meeting with a hopeful message.
- He thanked Ms. Pennington for sending out emails addressing employees' concerns for daily operational tasks and the safety of the County.
- He mentioned there are always good times and here are always bad times, but he is still continuing to be hopeful for transparency and a bit of the pie because it is a new year, a new day, a new age, and a new Director.
- Stated to please continue to keep transparency constant.

Freeholder Director Vanderslice announced the next meeting will be held Wednesday, February 15, 2017, at 7:00 in the Freeholder Meeting Room located on the first floor of the Old Salem Court House, with a 6:00pm Workshop Meeting prior.
