





PROSECUTOR'S OFFICE INSURANCE FRAUD REIMBURSEMENT PROGRAM**

WHEREAS, the Office of the Insurance Fraud Prosecutor has been designated by the Legislature to implement funding reimbursement for anti-insurance fraud activities, pursuant to N.J.S.A. 17:33A-28; and

WHEREAS, the Salem County Prosecutor's Office has received funding for anti-insurance fraud activities and wishes to apply for continued funding in the amount of \$247,736.34 for an action plan under the reimbursement program beginning January 1, 2018 and running through December 31, 2018; and

WHEREAS, the Board of Chosen Freeholders ("Board") recognizes the need to assist the Prosecutor's Office, the New Jersey Office of Insurance Fraud Prosecutor and law enforcement in an endeavor to effectively address the problem of insurance fraud in this County; and

WHEREAS, the project is a joint effort between the Office of the Insurance Fraud Prosecutor and the Salem County Prosecutor's Office for the purposes described in the application; and

WHEREAS, this agreement shall further be contingent upon availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget; and

WHEREAS, the Board of Chosen Freeholders has reviewed the application on file with the Clerk of the Board and has approved said request;

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that:

1. The project grant on file with the Clerk of the Board is approved and accepted.
2. The Attorney General has allocated funds dedicated for the purpose of reimbursing County Prosecutors for anti-insurance fraud activities.





WHEREAS, the Salem County Agriculture Development Board submitted a Planning Incentive Grant (PIG) application to the Salem County Agriculture Development Board (CADB) and the State Agriculture Development Committee (SADC), pursuant to the State Agriculture Retention and Development Act, N.J.S.A. 4:1C-11 et. Seq., the Planning Incentive Grant Program, N.J.S.A. 4:1C-43.1, and the regulations there under; and

WHEREAS, the application provided for the proposed acquisition of a Development Easement on the property owned by E & A Williams and designated on the municipal tax map as Block 18, Lot 3 and Block 29, Lot 4 in the Township of Quinton, County of Salem, State of New Jersey; and





**Memorandum of Understanding
New Jersey Department of Agriculture and County of Salem**

**Targeted States Education and Information for New Jersey Agricultural
Producers, September 30, 2017 to September 29, 2018**

This Memorandum of Understanding (MOU) is between the New Jersey Department of Agriculture (NJDA) and the County of Salem, hereafter known as Salem County.

The purpose of this memorandum is to document the understanding between the two agencies in delivering a program of crop insurance education & information to agricultural and horticultural producers as stated in Cooperative Agreement RM17RMETS524023 between the New Jersey Department of Agriculture and the United States Department of Agriculture, Risk Management Agency (USDA-RMA).

General Understanding

Acting in partnership with the USDA-RMA, NJDA and Salem County, with Salem County administering the program and paying the employees providing the crop insurance education, will ensure that an effective program of crop insurance education and information is established and delivered to farmers in New Jersey.

NJDA and Salem County will jointly abide by all provisions and requirements in the Cooperative Agreement RM17RMETS524023 between the NJDA and the USDA-RMA, for the period September 30, 2017 to September 29, 2018. All responsibilities, duties and functions stated in Cooperative Agreement RM17RMETS524023 are incorporated into this Memorandum of Understanding, copy attached.

NJDA will reimburse to Salem County costs, not to exceed \$175,646 that includes \$160,313 for staff salaries & benefits and \$15,333 for indirect charges for a comprehensive program of crop insurance education and training to New Jersey agricultural and horticultural producers.

Salem County will coordinate all activities with NJDA and provide detailed reports of all training to be conducted and such other information as required in the Cooperative Agreement between the NJDA and the USDA-RMA.

NJDA is responsible to draft a final written report in cooperation with Salem County to be completed by September 29, 2018 (within 90 days thereafter) and submitted by NJDA to USDA-RMA.

Effective Dates

All conditions and provisions of this Agreement shall become effective September 30, 2017 and shall continue in force until September 29, 2018.

New Jersey Department of Agriculture Responsibilities

The Department of Agriculture will:

1. Administer the New Jersey Crop Insurance Education and Information Program;
2. Reimburse Salem County \$175,646 through four payments for staff salaries & benefits (\$160,313) and indirect charges (\$15,333). Payments are reimbursement of costs that will be made upon timely receipt of deliverables listed under the sections Salem County Responsibilities and Salem County Deliverables;
3. Jointly work with Salem County in implementing the Statement of Work tasks and sub-tasks;
4. Jointly work with Salem County to mail newsletters, bulletins, and special announcements to New Jersey producers;
5. Announce meetings, planning sessions, and other events pertaining to crop insurance education, mail information materials to New Jersey farmers, and work jointly with Salem County in the promotion of program activities and meetings; and
6. Prepare and submit to USDA-RMA the quarterly financial reports: Request for Advance or Reimbursement (SF-270), Federal Financial Report (SF425), and Performance Progress Report (SF-PPR).

Salem County Responsibilities and Deliverables in partnership with NJDA and RMA

1. *Finalize the Delivery Plan*

- Hold initial planning meetings to target audiences, establish needs, plan sessions and workshops, review scope of work;
- Review crop insurance modifications for FY 2018;
- Schedule sessions, meetings and workshops; and
- Finalize program content.

2. *Assemble Instructional Materials*

- Complete a review of instructional materials used in FY2017;
- Identify changes in USDA policies and requirements for existing instructional materials, as well as in the 2018 Farm Bill, the materials to be used for the special emphasis topics relevant to NJ and specifically targeted producers;
- Develop, update and finalize instructional program materials including commodity specific materials such as: LGM Dairy/Milk Margin Protection Program information, as well as fruit, vegetable, grain, nursery, and apiculture, rainfall index, livestock products program information, Supplemental Coverage Options (SCO), and Whole Farm Revenue;
- Prepare commodity specific informational guides, handouts and training materials for workshops sessions, meetings, and one-on-one producer contacts;
- Maintain a host of on-line and interactive social media educational tools such as Facebook and Twitter;
- Identify apps or other software for on farm utilization to be shared with producers; and
- Mail postcards announcing sales closing deadlines and special time sensitive announcements.

3. *Develop and Conduct a Promotional Program*

- Develop up to 6 crop insurance bulletins to be published in the NJ Farmer newspaper;
- Utilize collaboration organizations to promote meeting announcements and program participation;
- Issue *Producer News* publications (winter) with direct mailings to producers;
- Publish in the *NJ Farmer* an 8-page supplement on key risk management topics;
- Place risk management promotional material in the *Lancaster Farming* newspaper;
- Modify social media platforms with current crop insurance information and upcoming meetings and locations;
- Work toward expanding apple and peach policies in non-assigned northern New Jersey counties; and
- Develop up to 9 newsletters on a rotating basis for apiculture, dairy, livestock products, rainfall index, Whole Farm Revenue, grain, nursery, fruit and processing vegetables.

4. *Deliver Training and Information to Producers and Agribusiness Professionals*

- Train 2,900 producers, including socially disadvantaged and limited resource producers (specifically targeted by RMA), on products and programs through meetings, sessions, one-on-one contacts before respective crop insurance closing dates;
- Provide crop insurance information through mailings, bulletins, & social media networks to 42,000 producers that will aid producers in making informed decisions on crop insurance as a means of managing risk in their farming operations;
- Conduct one crop insurance Train-the-Trainer for industry professionals;
- Staff exhibits at 9 agricultural conventions and trade show meetings and county farm fair(s);
- Conduct 8 crop insurance presentations at producer meetings throughout New Jersey;

- One-on-one contact with grain farmers on crop insurance programs at Perdue Grain Elevator facility during peak harvest for wheat, corn and soybean;
- Conduct sessions on retirement, transition and estate planning targeting risk management strategies;
- Conduct financial management sessions, including farm financial benchmarking, using Risk Management calculator in crop budgeting;
- Conduct/participate in sessions about crop insurance coverage for veterans, beginning and socially disadvantaged farmers;
- Meet one-on-one with key local crop insurance agents & professionals and disseminate information for non-local agents;
- Conduct one socially disadvantaged participation discussion session on risk management opportunities;
- Website displayed on the internet directory listing in *NJ Farmer*;
- Promote program and increase awareness through social networking websites, keep website current and up-to-date;
- Conduct one-on-one sessions with producers and provide educational material specifically designed to meet the needs of the individual; and
- Conduct sessions with individual farmers producing and marketing their products as part of a local or regional food system.

5. *Document All Educational Activities under the Crop Insurance Education Program*

- Develop an evaluation plan and documentation system for project;
- Assist NJDA in the preparation of progress reports;
- Maintain RME Activity Log reporting the number of producers receiving training;
- Submit salary/benefit/indirect charges expense document in a timely manner to the NJDA for reimbursement of expenses incurred to operate the crop insurance education program within the budgetary parameters approved by the Risk Management Agency USDA;
- Maintain publications log reporting the number of publications distributed;
- Upload copies of all risk management educational materials developed in the project to the Results Verification System for posting; and
- Assist NJDA in preparation of a final written report including an executive summary, listing of dates, places, instructors, and number of participants and instructional topics for all educational activities conducted Prepare an evaluation of the overall project, promotional activities, instructional materials, training delivery, success stories, and recommendations from project partners to improve future educational programs






