**RESOLUTION AUTHORIZING EXECUTION OF FEDERAL AID
AGREEMENT NO. 18-DT-BLA-784 FOR
HOOK ROAD, COUNTY ROAD #551, PHASE 1
IN PENNSVILLE AND CARNEYS POINT TOWNSHIPS
FOR THE COUNTY OF SALEM**

WHEREAS, the Federal Highway Administration has made Grant Funds available for the "RESURFACING OF HOOK ROAD, COUNTY ROAD #551, PHASE I"; and

WHEREAS, the County of Salem has determined that the "RESURFACING OF HOOK ROAD, COUNTY ROAD #551, PHASE I" from East Pittsfield Street, a local road (MP 2.16) to a point (MP 2.73) and from a point (MP 2.94) to Interstate 295 (MP 4.38) in the Townships of Pennsville and Carneys Point does meet the criteria established for Funding and is known as FEDERAL PROJECT NO. STP-SJ-0551(300), NJDOT JOB NO. 71105306 and FAP-2017-Salem County-02585; and

WHEREAS, HOOK ROAD, COUNTY ROAD #551, PHASE I was recommended by the County Engineer as a project meeting the funding criteria; and

WHEREAS, the New Jersey Department of Transportation has informed the County of Salem that a Federal Highway Administration Grant for \$1,152,218.00 has been Authorized for the CONSTRUCTION of this Road Reconstruction/Resurfacing Project.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of Chosen Freeholders as follows:

1. The FEDERAL AID AGREEMENT NO. 18-DT-BLA-784 between the New Jersey Department of Transportation and the County of Salem is hereby approved.
2. The Freeholder-Director and the Clerk of the Board of Chosen Freeholders are authorized to sign the FEDERAL AID AGREEMENT.
3. Authorization is given to the New Jersey Department of Transportation and Federal Highway Administration as requested.
