**RESOLUTION APPROVING THE EXECUTION OF**  
**CHANGE ORDER #4-FINAL ARC OF SALEM COUNTY**  
**PARKING LOT IMPROVEMENTS IN MANNINGTON TOWNSHIP**  
**FOR THE COUNTY OF SALEM**

**WHEREAS,** the County of Salem issued a Contract in the amount of \$254,369.50 to “SOUTH STATE, INC.” of Bridgeton, New Jersey for the ARC OF SALEM COUNTY PARKING LOT IMPROVEMENTS IN MANNINGTON TOWNSHIP FOR THE COUNTY OF SALEM, NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT 2016, AGREEMENT NO. 2016-02292-014800 on March 15, 2017 per Resolution # 2017-131; and

**WHEREAS,** N.J.A.C. 5:34-4.4(A) 3 requires that all change orders for capital projects be approved by the Board of Chosen Freeholders; and

**WHEREAS,** the County Engineer recommends approval of CHANGE ORDER NO. 4-FINAL, as more particularly described on the attached Salem County Change Order Form #4-FINAL for a PROJECT DECREASE of ELEVEN THOUSAND, THREE HUNDRED, SIXTY-EIGHT DOLLARS AND SEVENTY-FIVE CENTS (\$11,368.75), which in addition to Change Order #1, Change Order #2 and Change Order #3 represents a 3.75% Decrease in the Total Contract Cost; and

**WHEREAS,** this Project is Funded through the NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS, SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT; and

**WHEREAS,** the purpose of this Change Order #4-FINAL is to grant an extension of time and to approve Extra and Reduction Items, more particularly described on the attached Salem County Change Order Form #4-FINAL; and

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of Chosen Freeholders that this CHANGE ORDER #4-FINAL be and is hereby approved for execution for the ARC OF SALEM COUNTY PARKING LOT IMPROVEMENTS IN MANNINGTON TOWNSHIP FOR THE COUNTY OF

SALEM, NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS SMALL CITIES COMMUNITY DEVELOPMENT BLOCK GRANT 2016, AGREEMENT NO. 2016-02292-014800; and

**BE IT FURTHER RESOLVED** that the Freeholder-Director and the Clerk of this Board of Chosen Freeholders be authorized to execute said CHANGE ORDER NO. 4-FINAL.
