**RESOLUTION AUTHORIZING
A GRANT APPLICATION TO THE STATE OF NEW JERSEY
DEPARTMENT OF CHILDREN AND FAMILIES FOR FUNDING
FOR THE ESTABLISHMENT AND MAINTENANCE OF
A CHILD ADVOCACY CENTER FOR THE COUNTY OF SALEM**

WHEREAS, the New Jersey Department of Children and Families has been designated by the Legislature to implement funding reimbursement for the establishment and operation of Child Advocacy Centers in each County of the State of New Jersey; and

WHEREAS, the Salem County Prosecutor's Office wishes to make application for funding for the establishment and operation of a Child Advocacy Center in the County owned building located at 98 Market Street in the City of Sale, County of Salem and State of New Jersey ; and

WHEREAS, the Board of Chosen Freeholders ("Board") recognizes the need to assist the Prosecutor's Office, the New Jersey Department of Children and Families and law enforcement in an endeavor to provide a Child Advocacy Center in Salem County; and

WHEREAS, the project is a joint effort between the New Jersey Department of Children and Families and the Salem County Prosecutor's Office for the purposes described in the application; and

WHEREAS, this agreement shall further be contingent upon availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget; and

WHEREAS, the Board of Chosen Freeholders has reviewed the application on file with the Clerk of the Board and has approved said request;

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that:

1. The project grant on file with the Clerk of the Board is approved and accepted.
2. The Governor has allocated funds for the County Prosecutor to be dedicated for the purpose of establishing and operating a Child Advocacy Center.
3. The New Jersey Department of Children and Families shall be responsible for the receipt, review and approval of the applications for said funding.
4. The New Jersey Department of Children and Families shall initiate allocations to each applicant as authorized.

5. Five fully executed copies of this resolution shall be provided to the County Prosecutor forthwith.
