**RESOLUTION APPROVING AN AGREEMENT WITH THE
NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR
THE SALEM COUNTY MILL AND OVERLAY RESURFACING
PROGRAM, FISCAL YEAR 2017 – CONSTRUCTION
UNDER THE FEDERAL AID FUNDS EXCHANGE PROGRAM**

WHEREAS, the NEW JERSEY DEPARTMENT OF TRANSPORTATION has EXECUTED the Cost Reimbursement Agreement for the Salem County Mill and Overlay Resurfacing Program (Fiscal Year 2017) under the NEW JERSEY DEPARTMENT OF TRANSPORTATION, FEDERAL AID FUNDS EXCHANGE PROGRAM; and

WHEREAS, the County was approved for the RESURFACING AND SAFETY IMPROVEMENTS OF WATSONS MILL ROAD, COUNTY ROAD #672 (from Commissioner's Pike, County Road #581 MP 3.35 to Cohansey-Friesburg Road, County Road #635 MP 0.00 a distance of 3.34 miles in Alloway Township) and NEW BRIDGE ROAD, COUNTY ROAD #623 (from Harmersville-Pecks Corner Road, County Road #667 MP 3.31 to Beasley's Neck Road, County Road #651 MP 4.46 a distance of 1.24 miles in Lower Alloways Creek Township); and

WHEREAS, the County was AWARDED \$1,837,971.50 from the New Jersey Department of Transportation Federal Aid Funds Exchange Program for the above stated project. The Salem County Mill and Overlay Resurfacing Program, Fiscal Year 2017 – Construction will be governed by N.J.A.C. 16:20B-4.1, 16:20B-4.2 and 1:20A-4.1; counties are required to comply with these rules and provisions contained therein. The rules establish guidelines and procedures to be followed by Counties when administering contracts.

NOW, THEREFORE, BE IT RESOLVED that the Board of Chosen Freeholders of the County, formally approves the Cost Reimbursement Agreement for the above stated project.
