**RESOLUTION AWARDING A CONTRACT FOR PROVIDING COMPREHENSIVE DEPARTMENT OF TRANSPORTATION DRUG AND ALCOHOL TURNKEY COMPLIANCE MANAGEMENT SERVICES FOR THE COUNTY OF SALEM (DOT, FTA, FMCSA)**

**WHEREAS**, the Salem County Purchasing Agent as authorized Contracting Agent for the Board of Chosen Freeholders of the County of Salem requested, received, and opened sealed bids on Thursday, January 24, 2019, at 11:00 A.M., prevailing time for Providing Comprehensive Department of Transportation Drug and Alcohol Turnkey Compliance Management Services for the County of Salem (DOT, FTA, FMCSA) ; the receipt of which bids was duly advertised in accordance with the law and in such case made and provided; and


**WHEREAS**, all bid results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 5th Street, Suite 400, Salem, New Jersey, as required by Law; and

**WHEREAS**, it has been determined that the firm of **Compliance Oversight Solutions Ideal** has substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; and

**WHEREAS**, the Salem County Treasurer has certified that the funding for this contract shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget in Personnel/HR/Misc 9-01-20-104-158-218.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders of the County of Salem awards a two year contract for the provision of Drug and Alcohol Turnkey Compliance Management Services for the County of Salem, subject to the approval of the County Solicitor, to **Compliance Oversight Solutions Ideal** in the amount not to exceed \$ 34,590.00 (Thirty-Four Thousand, Five Hundred and Ninety Dollars and Zero Cents).
2. The contract shall commence retroactive to January 1, 2019 and terminate December 31, 2020, with two (2) additional one (1) year renewal options pursuant to N.J.S.A 40A:11-15(45); and shall be completed in full accordance with the terms and conditions of the contract.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said contracts upon compliance by the bidder with bond and insurance requirements of the specifications.
