**RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION
FOR STATE AID TO COUNTIES UNDER THE
NEW JERSEY DEPARTMENT OF TRANSPORTATION
LOCAL FREIGHT IMPACT FUND PROGRAM FOR FISCAL YEAR 2019**

WHEREAS, the NEW JERSEY DEPARTMENT OF TRANSPORTATION has made available funds under the NEW JERSEY DEPARTMENT OF TRANSPORTATION LOCAL FREIGHT IMPACT FUND for FISCALYEAR 2019; and

WHEREAS, the County has determined that the project, more particularly described in the GRANT AGREEMENT for the FISCAL YEAR 2019 LOCAL FREIGHT IMPACT FUND, as RESURFACING AND SAFETY IMPROVEMENTS TO STRAUGHNS MILL ROAD, COUNTY ROAD #643 from Interstate 295 to Penns Grove-Pedricktown Road, County Road #642 and the REHABILITATION OF STRAUGHNS MILL ROAD BRIDGE, COUNTY BRIDGE #1700-141 over Beaver Creek in OLDMANS TOWNSHIP FOR THE COUNTY OF SALEM.

NOW, THEREFORE, BE IT RESOLVED that the Board of Chosen Freeholders of the County, formally approves the Grant Application for the above stated project.
