RESOLUTION AWARDING CONTRACTS FOR PROVIDING SUPPLEMENTARY SNOW AND ICE REMOVAL SERVICES FOR THE COUNTY OF SALEM

WHEREAS, the Salem County Purchasing Agent, as authorized Contracting Agent for the Board of Chosen Freeholders of the County of Salem has requested, received and opened sealed proposals on October 25, 2017 at 11:00 AM prevailing time for Providing Supplementary Snow and Ice Removal Services for the County Salem. The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all bid results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 Fifth Street, in the County of Salem, New Jersey, as required by Law; and

WHEREAS, the following vendors who were awarded a contract for Supplemental Snow and Ice Removal Services by Resolution 2017-333 on November 15, 2017 have expressed an interest in exercising the first one (1) year renewal option as provided for in the original contract effective May 8, 2019 to May 7, 2020:

- Dobson Turf Management, LLC, Monroeville, NJ**
- Robert Gaines, Mullica Hill, NJ**
- Robinson Farms, Salem, NJ**
- South Jersey Farmers Exchange, Woodstown, NJ**
- T&H Construction LLC, Elmer, NJ**

WHEREAS, it has been determined that a need exists for additional contractors to assist the County with Snow and Ice Removal; and

WHEREAS, the Salem County Purchasing Agent, as authorized Contracting Agent for the Board of Chosen Freeholders of the County of Salem solicited and received and opened additional sealed proposals on Thursday, January 24, 2019 at 2:00 PM prevailing time for Providing Supplementary Snow and Ice Removal Services for the County Salem. The receipt of said bids were duly advertised in accordance with the law and in such case made and provided;

WHEREAS, provisions were made in the specifications to award contracts to all responsible bidders, to the best interest of the County of Salem in order to augment the existing pool of contractors; and

WHEREAS, additional bids were submitted by:

- HMS Concrete and Construction, LLC, Salem, NJ**
- Lacy's Express Inc. Pedricktown, NJ**
- Spartan Sealcoating & Property Maintenance LLC, Millville, NJ**

WHEREAS, the Salem County Treasurer has certified that funding for this contract shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon

the availability and appropriation of sufficient funds contained in the 2019 Budget of the County of Salem under the item Snow Removal (9-01-26-312-000-218) and Motor Vehicle Fines (T-19-56-857-735-300).

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders of the County of Salem hereby awards a one (1) year contract extension from May 8, 2019 to May 7, 2020 to **Dobson Turf Management, LLC, Monroeville, NJ; Robert Gaines, Mullica Hill, NJ; Robinson Farms, Salem, NJ; South Jersey Farmers Exchange, Woodstown, NJ; T&H Construction LLC, Elmer, NJ;** in accordance with the individual hourly rates as stated in their proposals; and
2. The Board of Chosen Freeholders of the County of Salem hereby awards two (2) year contracts from February 22, 2019 until February 21, 2021 with two (2) one year renewal options available pursuant to N.J.S.A. 40A:11-15(45) to **HMS Concrete and Construction, LLC, Salem, NJ; Lacy's Express Inc. Pedricktown, NJ; Spartan Sealcoating & Property Maintenance LLC, Millville, NJ** subject to the review and approval of the County Solicitor for their individual hourly rates as stated in their proposals.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said individual contracts with the above mentioned vendors upon compliance by the firm with all requirements and specifications.
