RESOLUTION AWARDING A RENEWAL CONTRACT FOR SUPPLYING GPS ELECTRONIC MONITORING FOR THE COUNTY OF SALEM

WHEREAS, the Salem County Purchasing Agent as authorized contracting agent for the Board of Chosen Freeholders of the County of Salem requested, received and opened sealed proposals on April 26, 2016 at 2:00 PM prevailing time for Supplying GPS Electronic Monitoring for the Salem County Correctional Facility; the receipt of which proposals were duly advertise in accordance with the law and in such case made and provided; and

WHEREAS, all bid results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 Fifth Street, in the County of Salem, New Jersey, as required by law; and

WHEREAS, it was been determined that the company of **Track Group Americas, Inc.** had substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; and

WHEREAS, all Requests for Proposal and Vendor Bid documents have become a part of the contract; and

WHEREAS, the Salem County Board of Chosen Freeholders awarded a contract on May 18, 2016 by Resolution 2016-210 to Track Group Americas, Inc. in the amount not to exceed \$40,000.00 (Forty Thousand Dollars); and

WHEREAS, the contract provided for additional renewal periods which both the County and vendor have consented to exercise; and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract shall be encumbered in account 9-01-25-281-520-218 Juvenile Detention/Misc. in accordance with N.J.A.C, 50:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders of the County of Salem hereby awards a renewal contract for Supplying GPS Electronic Monitoring for the Salem County Correctional Facility, subject to the approval of the County Solicitor, to **Track Group Americas, Inc.**, 405 S Main Street, Suite 700, Salt Lake City, UT 84111 in the amount of \$5.84 (Five Dollars and Eight Four Cents) per day per unit not to exceed \$40,000.00 (Forty Thousand Dollars and Zero Cents) per year.
2. The contract shall commence, retroactively, April 17, 2018 and terminate April 16, 2020 with no additional renewal periods available. The contract shall be completed in full accordance with the terms and conditions of the contract.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
