RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE NEW JERSEY JUDICIARY CUMBERLAND/GLOUCESTER/SALEM VICINAGE AND THE COUNTY OF SALEM FOR PROBATION ENRICHMENT AND TRANSPORTATION PROGRAM

WHEREAS, the Board of Chosen Freeholders ("Board") recognizes a continuing need to assist the Salem County Youth Services Commission ("SCYSC") and County Council on Juvenile Justice System Improvement ("CJJSI") in efforts to provide approved Juvenile Detention Alternatives Initiative ("JDAI") Innovations programming for youth adjudicated delinquent; and

WHEREAS, the SCYSC and CJJSI approved a grant application from the New Jersey Juvenile Justice Commission for the JDAI Grant Program in accordance with the certified assurances, grant conditions, award notice on file with the Clerk of the Board; and

WHEREAS, the Board recognizes the New Jersey Judiciary Cumberland/Gloucester/Salem Vicinage ("Vicinage") as an approved JDAI funding grantee in the amount of Seven Thousand, Four Hundred and Twenty-Five Dollars and Zero Cents (\$7,425.00) to facilitate Orientation and Probation Officer Overtime Stipends for the Probation Enrichment and Transportation Program (P.E.T.) for at-risk youth; and

WHEREAS, the Board recognizes the grant reimbursement contract is for a one-year period retroactive to January 1, 2019 to December 31, 2019.

NOW THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that:

1. An Agreement between the New Jersey Judiciary Cumberland/Gloucester/Salem Vicinage and County of Salem for a Probation Enrichment Program (P.E.T.) is hereby approved.
2. The Freeholder Director and Clerk of the Board are authorized to sign the Agreement, evidencing the consent and agreement of the County of Salem to the terms and conditions contained therein.
3. The Probation Enrichment Program Summary on file with the Clerk of the Board is approved and accepted.
4. The Deputy Director of Operations, the Chief Finance Officer, the Salem County Youth Services Coordinator from the Salem Inter Agency Council of Human Services Inc., as well as any other necessary parties, are hereby authorized and directed to execute all project grant documents provided by the Juvenile Justice Commission.

5. Three fully executed copies of this resolution shall be provided to the Salem County Inter Agency Council of Human Services and one fully executed copy shall be provided to the New Jersey Judiciary Cumberland/Gloucester/Salem Vicinage forthwith.


