RESOLUTION AUTHORIZING THE DONATION OF A VEHICLE TO SALEM COUNTY VO-TECHNICAL SCHOOL (NUNC PRO TUNC)

WHEREAS, the County of Salem (County) is a body politic and corporate of the State of New Jersey with main offices located at 94 Market Street, Salem, New Jersey 08079; and

WHEREAS, the Salem County Vocational and Technical Education School District (District) is a sanctioned school district with offices located at 880 Route 45, Pilesgrove, NJ 08098; and

WHEREAS, the County of Salem has determined that a 2004 Ford Crown Victoria, 4 door automobile bearing the vehicle identification number 2FAHP 71W44 X1237 61 is no longer needed for County purposes; and

WHEREAS, the Salem County Vocational and Technical Education School District (District) has expressed an interest in owning the automobile for use in the Auto Collision Repair Technology; Automotive Technology and Law Enforcement & Public Safety programs; and

WHEREAS, the Salem County Administrator recommends the donation of the said vehicle; and

WHEREAS, N.J. S.A. 40A:12-21.1 permits the sale of County property to a public entity without compliance with any other law governing disposal of personal property by Counties or Municipalities, for a consideration, which may be nominal; and

WHEREAS, N.J. S.A. 40A:12-21.1 stipulates that the property being transferred shall be used only for the purposes of that organization or association, and to render those services or to provide those facilities as may be agreed upon, and not for commercial business, trade or manufacture, and that if the personal property is not used in accordance with that limitation, ownership thereto shall revert to the county or municipality.

NOW THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that:

1. The County donates 2004 Ford Crown Victoria, 4 door automobile bearing the vehicle identification number 2FAHP 71W44 X1237 61 (Nunc Pro Tunc) in return for the payment of One Dollar (\$1.00).
2. The County Purchasing Agent is authorized to execute any and all documents necessary to effectuate the donation/sale of said automobile, including the transfer the NJ Department of Motor Vehicles Title.
