(FY 2018 – DESIGN)  
FEDERAL AID AGREEMENT NO. 18-DT-BLA-783**

**WHEREAS,** the Salem County Engineer's Office made application to the New Jersey Department of Transportation for funds from the SURFACE TRANSPORTATION BLOCK GRANT PROGRAM; and

**WHEREAS,** the Board previously granted approval of the aforesaid application by Resolution No. 2018-347, dated October 17, 2018, and, therefore, approves acceptance of this Grant; and


**WHEREAS,** the New Jersey Department of Transportation has obligated funds for the "DESIGN AND SURVEY OF WILLOW GROVE ROAD, COUNTY ROAD #639" from Centerton Road, County Road #610 (MP 0.0±) to Alvine Road, County Road #655 (MP 2.77±) in Pittsgrove Township in the amount of \$43,881.00 in accordance with the notice of "Execution of Funding Agreement" letter dated February 6, 2019; and

**WHEREAS,** no funding match is required for this Grant; and

**WHEREAS,** this Grant and Project are to be referenced as FEDERAL PROJECT NO. STP-SJ-0639(300), CONTRACT ID #19 70956, NEW JERSEY DEPARTMENT OF TRANSPORTATION JOB NO. 7110316, and FAP-2018-SALEM COUNTY-02837.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem that:

1. The grant AGREEMENT, as executed and on file with the Salem County Engineer's Office is support and accepted.
