**RESOLUTION ACCEPTING GRANT FUNDING  
FOR THE ENGINEER'S OFFICE  
FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION  
FOR CENTERTON TRAFFIC SIGNAL IMPROVEMENTS  
FEDERAL AID AGREEMENT NO. 08-DT-BLA-777**

**WHEREAS,** the Salem County Engineer's Office made application to the New Jersey Department of Transportation for funds from the TRANSPORTATION TRUST FUND; and

**WHEREAS,** the Board previously granted approval of the aforesaid application by Resolution No. 2018-326, dated October 3, 2018, and, therefore, approves acceptance of this Grant; and

**WHEREAS,** the New Jersey Department of Transportation has obligated funds for the "CENTERTON TRAFFIC SIGNAL IMPROVEMENTS" to the signalized intersection of Almond road, County Road #540 and Centerton Road, County Road #553 in Pittsgrove Township in the amount of \$167,194.65 in accordance with the notice of "Execution of Funding Agreement" letter dated February 14, 2019; and

**WHEREAS,** no funding match is required for this Grant; and

**WHEREAS,** this Grant and Project are to be referenced as FEDERAL PROJECT NO. CMAQ-0553(353), CONTRACT ID #19 70937, NEW JERSEY DEPARTMENT OF TRANSPORTATION JOB NO. 7110317, and FAP-2017-SALEM COUNTY-02567.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem that:

1. The grant AGREEMENT, as executed and on file with the Salem County Engineer's Office is support and accepted.
