**RESOLUTION AUTHORIZING THE AGREEMENT WITH THE GOVERNOR'S COUNCIL
ON ALCOHOLISM AND DRUG ABUSE FOR THE
MUNICIPAL ALLIANCE TO PREVENT ALCOHOLISM AND DRUG ABUSE
FOR JULY 1, 2019 TO JUNE 30, 2020**

WHEREAS, the New Jersey Governor's Council on Alcoholism and Drug Abuse has set aside \$137,801.00 to finance the Salem County Municipal Alliance to Prevent Alcoholism and Drug Abuse per the DEDR formula; and

WHEREAS, State regulations that Salem County's Municipal Alliances be funded according to plans approved by the Salem County Advisory Committee on Alcoholism and Drug Abuse; and

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse has prepared a Letter of Agreement with Salem County to finance the Municipal Alliance for July 1, 2019 through June 30, 2020; and

NOW THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that the Freeholder Director and Clerk of the Board of Chosen Freeholders are hereby authorized to sign a Letter of Agreement with the Governor's Council on Alcoholism and Drug Abuse for the Salem County Municipal Alliance for July 1, 2019 to June 30, 2020.




This Letter of Agreement will remain valid for the period of July 1, 2019 to June 30, 2020 contingent upon full compliance to the stipulations of the Governor's Council on Alcoholism and Drug Abuse municipal alliance requirements.

If, through any cause within its control, the county (hereinafter the GRANTEE) shall fail to fulfill in a timely and professional manner the obligations under this agreement, or if the GRANTEE should violate any of the covenants, provisions or stipulations of this Letter of Agreement, the Governor's Council on Alcoholism and Drug Abuse (hereinafter the GCADA) will thereupon have the right to terminate this agreement by written notice to the GRANTEE and specifying the effective date thereof, at least thirty (30) days prior of the termination date.

Funds issued by the COUNCIL to the GRANTEE under this Letter of Agreement shall not exceed \$137,801.00, which is your allocation per the DEDR formula.
