**RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT BETWEEN THE SALEM COMMUNITY COLLEGE AND THE COUNTY OF SALEM FOR STUDENT NURSING SUPPORT SERVICES FOR THE SALEM COUNTY DEPARTMENT OF HEALTH**

**WHEREAS**, The Salem County Board of Chosen Freeholders and the Salem Community College wish to enter into a Shared Services Agreement to provide a hands on learning experience for students of the Community College's Nursing Program; and

**WHEREAS**, the Salem County Department of Health may utilize student nurses enrolled in the Salem Community College Nursing Program to assist them, from time to time, in administering vaccines and dispensing information; and

**WHEREAS**, the Salem County Board of Chosen Freeholders and Salem Community College Board of Trustees have deemed it desirable to adopt resolutions authorizing this Shared Services Agreement; and

**WHEREAS**, N.J.S.A. 40:65A-1 et seq. specifically authorized local government units, including counties and municipalities, to enter into shares services agreements; and

**WHEREAS**, the initial term of this Shared Services Agreement shall be from September 1, 2019 until August 31, 2020 and shall be automatically renewed from September 1 through August 31 of each year up to ten (10) years, expiring on August 31, 2029, unless terminated in writing by either party.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem as follows:

1. The County of Salem and the Salem Community College agree to enter into a Shared Service Agreement to provide Student Nursing Support Services in accordance with the terms and conditions contained in the agreement.
2. The initial term of this Agreement shall be for one year and shall commence on September 1, 2019 and terminate on August 31, 2020.
3. The Freeholder Director and the Clerk of the Board are hereby authorized to execute said Shared Services Agreement in conjunction with Salem County, subject to the review of the Salem County Counsel.
4. The Freeholder Director and the Clerk of the Board shall be authorized to execute said Shared Service agreement.
