RESOLUTION AWARDING A RENEWAL CONTRACT FOR HOME DELIVERED NUTRITION STATE HOME DELIVERED MEALS UNDER THE OLDER AMERICANS ACT-AREA PLAN GRANT

WHEREAS, the Salem County Purchasing Agent as authorized contracting agent for the Board of Chosen Freeholders of the County of Salem requested, received and opened sealed proposals on September 12, 2018 at 2:00 PM prevailing time for Providing Services and Programs for the Salem County Senior Residents 60 Years of Age or Older and Limited Disabled Residents; the receipt of which proposals was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all bid results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 Fifth Street, in the County of Salem, New Jersey, as required by law; and

WHEREAS, it was been determined that **Meals On Wheels of Salem County** had substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; and

WHEREAS, all Requests for Proposal and Vendor Bid documents have become a part of the contract; and

WHEREAS, the Salem County Board of Chosen Freeholders awarded a contract on October 17, 2018 by Resolution 2018-351 to Meals On Wheels in the amount not to exceed \$15,373.00 (Fifteen Thousand Three Hundred Seventy Three Dollars) in SHDM Funds; and \$1,789.00 (One Thousand Seven Hundred Eighty Nine Dollars) in USDA funds; and a required Provider Match of \$3,843.00 (Three Thousand Eight Hundred Forty Three Dollars); and

WHEREAS, the contract provided for additional renewal periods which both the County and vendor have consented to exercise; and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract shall be encumbered in account G-02-41-700-20B-303 Area Plan Grant in accordance with N.J.A.C, 50:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders of the County of Salem hereby awards a renewal contract for providing Home Delivered Meal Services Title III C2 for the Salem County Office On Aging, subject to the approval of the County Solicitor, to **Meals On Wheels of Salem County**, 90 Market Street, Salem, NJ 08079 in the amount not to exceed \$15,373.00 (Fifteen Thousand Three Hundred Seventy Three Dollars) in SHDM Funds; and \$1,789.00 (One Thousand Seven Hundred Eighty Nine Dollars) in USDA funds; and a required Provider Match of \$3,843.00 (Three Thousand Eight Hundred Forty Three Dollars); at a Cost Per Unit of \$12.07 during 2020.
2. The contract period is January 1, 2020 through December 31, 2020. The contract shall be completed in full accordance with the terms and conditions of the contract.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
