RESOLUTION AUTHORIZING A GRANT APPLICATION FOR THE PROSECUTOR'S OFFICE FROM THE NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY FOR THE BODY ARMOR REPLACEMENT FUND (BARF) PROGRAM

WHEREAS, the Board of Chosen Freeholders (Board) recognizes a continuing need to assist the Prosecutor's Office, the New Jersey Department of Law and Public Safety and law enforcement in offsetting the costs of purchasing body vests for law enforcement officers; and

WHEREAS, the Salem County Prosecutor's Office wishes to apply for and has submitted an application for funding for the Body Armor Replacement Fund (BARF) Program for a five year period, beginning January 1, 2019; and
