RESOLUTION AUTHORIZING A GRANT APPLICATION FOR THE SHERIFF'S OFFICE FROM THE NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY FOR THE BODY ARMOR REPLACEMENT FUND (BARF) PROGRAM

WHEREAS, the Board of Chosen Freeholders (Board) recognizes a continuing need to assist the Sheriff's Office, the New Jersey Department of Law and Public Safety and law enforcement in offsetting the costs of purchasing body vests for law enforcement officers; and

WHEREAS, the Salem County Sheriff's Office wishes to apply for and has submitted an application for funding for the Body Armor Replacement Fund (BARF) Program for a five year period, beginning January 1, 2019; and

NOW THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that:

- 1) The project grant application on file with the Clerk of the Board has been reviewed and approved by the Board of Chosen Freeholders
