**RESOLUTION OF THE BOARD OF CHOSEN FREEHOLDERS ACCEPTING A GRANT FROM THE NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY FOR OPERATION HELPING HAND REIMBURSEMENT GRANT FUNDING FOR THE PROSECUTOR'S OFFICE [Subaward No. OHH-17-2019]**

**WHEREAS**, the Board of Chosen Freeholders ("Board") recognizes a continuing need to assist the Prosecutor's Office, the New Jersey Department of Law and Public Safety ("Department") and law enforcement in endeavors to effectively address the Opioid Crisis in Salem County; and

**WHEREAS**, the Department has approved a grant application from the Salem County Prosecutor's Office for the Operation Helping Hand Reimbursement Grant Program in accordance with the grant acceptance letter on file with the Clerk of the Board; and

**WHEREAS**, the Board recognizes the grant reimbursement is for a one (1) year period from September 1, 2019 to August 31, 2020, with total funding of \$100,000.00; and

**WHEREAS**, the Board granted the approval of this same funding for the previous period of September 1, 2018 to August 31, 2019.

**WHEREAS**, the Board approved the application for this funding on September 4, 2019, by execution of Resolution No. 2019-329;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem that:

- 1) The Project Grant on file with the Clerk of the Board is approved and accepted.
- 2) The County Prosecutor, the Chief Finance Officer, the Project Contact person from the Prosecutor's Office, as well as any other necessary parties, are hereby authorized and directed to execute all project grant documents provided by the Division.
- 3) Five fully executed copies of this resolution shall be provided to the County Prosecutor forthwith.
