**RESOLUTION AUTHORIZING EXECUTION OF NEW JERSEY DEPARTMENT OF TRANSPORTATION, LOCAL AID AND ECONOMIC DEVELOPMENT FEDERAL AID AGREEMENT NO. 19-DT-BLA-804 FOR THE SALEM COUNTY MILL & OVERLAY RESURFACING PROGRAM (FY 2018 CONSTRUCTION)**

**WHEREAS,** the New Jersey Department of Transportation has made Funds available under the "Federal Aid Program" for the Design and Construction of Road and Bridge Projects; and

**WHEREAS,** the County of Salem has determined that the "Resurfacing of Willow Grove Road, County Road #639", from Centerton Road, County Road #610 (MP 0.00) to Alvine Road, County Road #655 (MP 2.77), in Pittsgrove Township does meet the criteria established for Funding and is known as NEW JERSEY DEPARTMENT OF TRANSPORTATION, LOCAL AID AND ECONOMIC DEVELOPMENT FEDERAL AID AGREEMENT NO. 19-DT-BLA-804, FEDERAL PPROJECT NO. STBGP-SJ-0639(303), NJDOT JOB NO. 7110320 and FAP-2019-Salem County-00015; and

**WHEREAS,** the RESURFACING of this Road was recommended by the County Engineer due to the deteriorating condition of the road; and

**WHEREAS,** the New Jersey Department of Transportation has informed the County of Salem that a Federal Aid Program Grant for \$1,448,484.15 has been Authorized for this CONSTRUCITON Project.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of Chosen Freeholders as follows:

1. The NEW JERSEY DEPARTMENT OF TRANSPORTATION, LOCAL AID AND ECONOMIC DEVELOPMENT FEDERAL FUNDS AGREEMENT NO. 19-DT-BLA-804 between the New Jersey Department of Transportation and the County of Salem is hereby approved.
2. The Freeholder-Director and the Clerk of the Board of Chosen Freeholders are authorized to sign the FEDERAL AID AGREEMENT – COST REIMBURSEMENT AGREEMENT.
3. Authorization is given to the New Jersey Department of Transportation as requested.
