RESOLUTION AUTHORIZING LETTER OF AGREEMENT TO PROVIDE MANAGEMENT SERVICES FOR THE SALEM COUNTY TWELVE-HOUR INTOXICATED DRIVER RESOURCE CENTER PROGRAM

WHEREAS, the County of Salem, as a Contracting Unit, may, without public advertising for bids, and without the use of the Competitive Contracting model, negotiate and award by Resolution of the Governing Body, Contracts, if the subject matter consists of the supplying or rendering of any concession by a Not-for-Profit Entity, if determined and recognized as such by County Counsel, and pursuant to the Provisions of Local Public Contracts Law, N.J.S.A. 40A:11 et seq., and Local Public Contracts Law Rules, N.J.S.A. 5:30 et seq.; and

WHEREAS, the County of Salem desires to enter into an Agreement with **The Southwest Council, Inc.**, a Not-for-Profit Entity, to provide Management Services for the Salem Twelve-Hour County Intoxicated Driver Resource Center (IDRC), and which Agreement shall be subject to all of the Terms and Conditions as set forth herein; and

WHEREAS, funding for this Agreement need not be certified as no County of Salem Funds shall be expended for the performance of this Concessionary Agreement.

NOW THEREFORE, BE IT RESOLVED by the Salem County Board of Chosen Freeholders as follows:

- The County of Salem is hereby authorized to enter into a Letter of Agreement with The Southwest Council, Inc., 1405 N. Delsea Drive, Vineland, NJ 08360, subject to the review of the Salem County Solicitor, for providing Management Services for the Salem County Twelve-Hour Intoxicated Driver Resource Center commencing January 1, 2020 and terminating December 31, 2020.
- 2. The Freeholder Director and the Clerk of the Board of the Salem County Board of Chosen Freeholders shall be authorized to execute said Agreement.
