RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION FOR STATE AID TO COUNTIES UNDER THE NEW JERSEY DEPARTMENT OF TRANSPORTATION RAIL FREIGHT ASSISTANCE PROGRAM FOR FISCAL YEAR 2020

WHEREAS, the NEW JERSEY DEPARTMENT OF TRANSPORTATION has made available funds under the NEW JERSEY DEPARTMENT OF TRANSPORTATION RAIL FREIGHT ASSISTANCE PROGRAM for FISCAL YEAR 2020; and

WHEREAS, the County has determined that the project, more particularly described in the GRANT AGREEMENT for the FISCAL YEAR 2020 RAIL FREIGHT ASSISTANCE PROGRAM, as CHESTNUT RUN CULVERT REPLACEMENT, approximate length of project 100 feet, located in THE BOROUGH OF WOODSTOWN FOR THE COUNTY OF SALEM; and

WHEREAS, the New Jersey Department of Transportation is to provide \$834,480.00 for the Fiscal Year 2020 Rail Freight Assistance Program to cover eligible project costs, the required sponsor/Salem County share is estimated to be \$93,520.00, for a total eligible project cost budget of \$928,000.00.

NOW, THEREFORE, BE IT RESOLVED that the Board of Chosen Freeholders of the County, formally approves the Grant Application for the above stated project.

BE IT FURTHER RESOLVED that the Freeholder Director and Clerk of the Board are hereby authorized to submit an electronic Grant Application identified as RAIL-2020-Salem County-010 to the New Jersey Department of Transportation on behalf of the County of Salem.

BE IT FURTHER RESOLVED that the Salem County Administrator is hereby authorized to sign the required "Applicant Submission Certification" form on behalf of the County of Salem.

BE IT FURTHER RESOLVED that the Freeholder Director and Clerk of the Board are hereby authorized to sign the Grant Agreement on behalf of the County of Salem and that their signature constitutes acceptance of the Terms and Conditions of the Grant Agreement and approves the execution of the Grant Agreement.
