RESOLUTION AWARDING CULTURAL & HERITAGE COMMISSION 2020 GRANT DOLLARS FROM THE NEW JERSEY STATE COUNCIL ON THE ARTS AND THE NEW JERSEY HISTORICAL COMMISSION

WHEREAS, the Salem County Board of Freeholders through the Salem County Cultural & Heritage Commission was awarded grant money from the New Jersey State Council on the Arts, a division of the New Jersey Department of State and Partner Agency with the National Endowment for the Arts, and the New Jersey Historical Commission, a division of the New Jersey Department of State; and

WHEREAS, the Salem County Cultural & Heritage Commission reviewed said applications and the recommendations of the Arts Grant Independent Review Panel and by unanimous vote moved to award Arts Grant dollars to Nanticoke Leni-Lenape Indians of New Jersey - \$6,000.00, Oakwood Summer Theatre - \$5,000.00, One Village Alliance - \$543.00, Pennsville Township Economic Development Commission - \$2,000.00, Salem Community College - \$4,000.00, Salem Community College Foundation - \$5,000.00, Salem County Arts Alliance - \$4,500.00, Salem County Art League - \$5,300.00, Stand Up for Salem - \$5,000.00, Third Star Fibre Guild - \$1,000.00, Woodstown Monthly Meeting - \$5,500.00 and Woodstown Rotary - \$3,000.00; and

WHEREAS, the Salem County Cultural & Heritage Commission also reviewed said applications and the recommendations of the History Grant Independent Review Panel and by unanimous vote moved to award History Grant dollars to the Fort Mott Park Association - \$1,000.00, Greater Elmer Area Historical Society - \$2,200.00, and Salem County Historical Society - \$12,162.00; and

NOW THEREFORE, BE IT RESOLVED that the Board of Chosen Freeholders of the County of Salem hereby agrees with the recommendations of Salem County Cultural & Heritage Commission and awards Arts and History Grants as proposed.
