RESOLUTION AUTHORIZING AN EXTENSION OF AN AGREEMENT BETWEEN THE SERVICES TO OVERCOME DRUG ABUSE AMONG TEENAGERS, INC. d/b/a SODAT OF NJ THE COUNTY OF SALEM FOR PROBATION ENRICHMENT AND TRANSPORTATION PROGRAM 2020

WHEREAS, the County of Salem applied for, received and accepted a New Jersey Juvenile Detention Alternatives Initiative Innovation Funding Grant ("Grant") for CY 2020 in the total amount of \$120,000.00 (One Hundred Twenty Thousand Dollars and Zero Cents); and

WHEREAS, the grant includes a component for Probation Enrichment and Transportation Program in the total amount of \$45,512.00 (Forty-Five Thousand, Five Hundred and Twelve Dollars and Zero cents); and

WHEREAS, the Request for Proposal and Contract with SODAT of NJ issued for CY 2019 provided for one (1) additional one (1) year renewal term; and

WHEREAS, the County of Salem and Salem County Youth Services Commission wishes to exercise said renewal option; and

WHEREAS, under the terms of the 2020 Grant Salem County must contract directly with a service provider for Probation Enrichment and Transportation services totaling \$38,087.00 (Thirty-Eight Thousand, Eighty Seven Dollars and Zero Cents) on behalf of the Salem County Youth Services Commission; and

WHEREAS, the Salem County Treasurer has certified that funding for this Agreement shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds contained in the 2020 Temporary and Final Budget of the County of Salem under the item JDAI-Probation Enrichment Transportation Program (G-02-41-765-20C-303).

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders of the County of Salem authorizes an extension of an Agreement with SODAT of NJ to provide Probation Enrichment and Transportation services totaling \$38,087.00 (Thirty-Eight Thousand, Eighty Seven Dollars and Zero Cents) subject to the review of County Counsel and AOC Counsel.
2. The Agreement shall commence January 1, 2020 and terminate December 31, 2020, which shall be completed in full accordance with the terms and conditions of the Grant.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said contracts.


