RESOLUTION FOR COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT LAW FOR THE COUNTY OF SALEM

WHEREAS, Public Law 1975, Chapter 231, Open Public Meetings Act was enacted into law on October 21, 1975, and took effect on January 19, 1976; and

WHEREAS, the declared purpose of the Open Public Meetings Act Law, also referred to as the "Sunshine Law", is to ensure the rights of all citizens to have advance notice of and to attend all meeting of public bodies at which any business affecting the public is discussed or acted upon, with certain limited exceptions to protect the public interest and preserve personal privacy; and

WHEREAS, the Salem County Board of Chosen Freeholders does hereby wish to comply with the general requirements of the law.

NOW THEREFORE, BE IT RESOLVED that the Salem County Board of Chosen Freeholders does hereby establish the following schedule of regular meetings to be held by the said Board during the year 2020 at 6:00 pm in the Olde Salem Court House, 104 Market Street, Salem, New Jersey, 08079, unless otherwise specified, to wit October 21 at Penns Grove Municipal Building, 1 State Street, Penns Grove, NJ. Emergency and inclement weather cancellations will be posted on the County website, Salem County Government Facebook page, and on the County phone system recording at (856) 935-7510.


