RESOLUTION AUTHORIZING A ONE YEAR EXTENTION OF A CONTRACT FOR PROVIDING INMATE DENTAL CARE TO THE SALEM COUNTY CORRECTIONAL FACILITY

WHEREAS, the Salem County Purchasing Agent, as authorized Contracting Agent for the Board of Chosen Freeholders of the County of Salem has requested, received and opened sealed proposals on February 9, 2016 at 2:00 pm prevailing time for Providing Inmate Dental Care for the Salem County Correctional Facility and the receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all bid results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 5th Street, Suite 400, Salem, NJ, in the County of Salem, New Jersey, as required by Law; and

WHEREAS, it had previously been determined that **Dentrust Optimized Care Solutions (d/b/a Dentrust Dental, PA)** has substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; and

WHEREAS, The Salem County Treasurer has certified that the funding for this Contract shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County temporary and/or permanent budget; and

WHEREAS, on February 17, 2016 the Salem County Board of Chosen Freeholders authorized a contract via Resolution 2016-113 to **Dentrust Dental, P.A.**, 6097 Easton Road, Pipersville, PA 18947 in the amount not to exceed \$38,352.00 (Thirty-Eight Thousand Three Hundred Fifty-Two Dollars and Zero Cents) for a period of two (2) years commencing, retroactively, February 1, 2016 and terminating January 31, 2018 with an option for two (2), one (1) year renewals; and

WHEREAS, on March 23, 2018 the Salem County Board of Chosen Freeholders authorized a renewal contract via Resolution 2016-113 to **Dentrust Dental, P.A.**, 6097 Easton Road, Pipersville, PA 18947 in the amount not to exceed \$38,352.00 (Thirty-Eight Thousand Three Hundred Fifty-Two Dollars and Zero Cents) for a period of two (2) years commencing, retroactively, February 1, 2016 and terminating January 31, 2018

WHEREAS, on March 23, 2018 the Salem County Board of Chosen Freeholders authorized a one-year extension by Resolution 2018-136 to the contract in the amount not to exceed \$38,352.00 (Thirty-Eight Thousand Three Hundred Fifty-Two Dollars and Zero Cents) for the period of February 1, 2018 to January 31, 2019 with one (1) year renewal option available; and

WHEREAS, the Salem County Correctional Facility Warden wishes to exercise the final one-year extension of the contract commencing retroactively to February 1, 2020 and terminating January 31, 2021 in the amount not to exceed \$39,000.00 (Thirty-Eight Thousand Three Hundred Fifty-Two Dollars and Zero Cents); and

WHEREAS, **Dentrust Optimized Care Solutions** (i.e. **Dentrust Dental P.A.**) has consented to the one-year extension of the contract.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders of the County of Salem hereby authorizes a one year (12 month) extension of a contract for Providing Inmate Dental Care to the Salem County Correctional Facility, subject to the review of the County Solicitor, to **Dentrust Optimized Care Solutions** (i.e. **Dentrust Dental P.A.**) 6097 Easton Road, Pipersville, PA 18947 in the amount not to exceed \$39,000.00 (Thirty-Nine Thousand Dollars and Zero Cents). This shall be completed in full accordance with the terms and conditions of the contract.

2. The contract shall be for a period of one (1) year commencing, retroactively, February 1, 2020 and terminating January 31, 2021 with no additional renewal periods available.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
