**RESOLUTION AMENDING THE 2020 TEMPORARY CAPITAL BUDGET**

**WHEREAS,** the County of Salem deems it necessary and desirable to provide for a capital project not previously reflected in the 2020 Temporary Capital Budget; and

**WHEREAS,** N.J.A.C. 5:30-4.4B provides that the Temporary Capital Budget of a governing body shall be amended to reflect any provisions, changes or inconsistencies with said Capital Budget; and

**NOW THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem that the 2020 Temporary Capital Budget shall be amended to reflect the addition of Ordinance 2020-02–Improvements to the Courthouse and the Administration Building and the Construction of an Adjoining Addition thereto, by and in the County of Salem, State of New Jersey, not previously provided for in the Temporary Capital Budget.


**BE IT FURTHER RESOLVED** that the below form, as promulgated by the Local Finance Board shall represent the amended Capital Budget for the year.
