RESOLUTION AWARDING A CONTRACT SUPPLYING NEW WEAPONS FOR THE SALEM COUNTY PROSECUTOR AND SHERIFF OFFICES

WHEREAS, the Salem County Purchasing Agent as authorized Contracting Agent for the Board of Chosen Freeholders of the County of Salem requested, received, and opened sealed proposals on March 10, 2020 at 11:00 A.M. prevailing time for Supplying New Weapons (Pistols) for the County of Salem Sheriff and Prosecutor's Offices; the receipt of which proposals was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, all proposal results and recommendations for contract award are on file in the Office of the Purchasing Agent, 110 Fifth Street, Salem, New Jersey, as required by law; and

WHEREAS, the Salem County Prosecutor's Office, Salem County Sheriff's Office and Salem County Purchasing Agent have determined that the company of Atlantic Tactical, Inc. substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem. Said bid documents shall become a part of the contract; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders of the County of Salem hereby awards a contract for the Supplying New Weapons (Pistols) for the County of Salem Sheriff and Prosecutor's Offices subject to the review of the County Solicitor, to Atlantic Tactical, Inc. 763 Corporate Circle, New Cumberland, PA 17070. The cost of which shall not exceed \$ 86,737.50 (Eighty-Six Thousand, Seven Hundred Thirty-Seven Dollars and Fifty Cents).

2. This contract shall commence on March 19, 2020 upon issuance of the Purchase Order and shall be completed in full accordance with the terms and conditions of the contract.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


