**RESOLUTION AWARDING CONTRACTS FOR PROVIDING DRUG AND ALCOHOL TREATMENT SERVICES FOR THE SALEM COUNTY ALCOHOL AND DRUG SERVICES OFFICE**

**WHEREAS**, the Salem County Purchasing Agent as authorized Contracting Agent for the Board of Chosen Freeholders of the County of Salem requested, received, and opened sealed proposals on April 7, 2020, at 11:00 AM prevailing time for Drug and Alcohol Treatment Services for the Salem County Alcohol and Drug Services Office; the receipt of which proposals was duly advertised in accordance with the law and in such case made and provided; and

**WHEREAS**, all proposal results and recommendations for contract award are on file in the office of the Purchasing Agent, 110 5<sup>th</sup> Street, Suite 400 in the County of Salem, Salem, New Jersey, as required by law; and

**WHEREAS**, the Salem County Treasurer has certified that the funding for these contracts shall be encumbered in accordance with N.J.A.C, 50:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's 2020 Budget of the County of Salem under the item Alcohol Comprehensive Grant G-02-41-701-20C-303.
