**RESOLUTION AUTHORIZING THE DONATION OF A VEHICLE TO  
ELSINBORO TOWNSHIP**

**WHEREAS**, the County of Salem (County) is a body politic and corporate of the State of New Jersey with main offices located at 94 Market Street, Salem, New Jersey 08079; and

**WHEREAS**, the Elsinboro Township is a politic and corporate of the State of New Jersey with offices located at 619 Salem Ft-Elfsborg Road, Salem, NJ 08079; and

**WHEREAS**, the County of Salem has determined that a 2006 Dodge Durango, bearing the vehicle identification number 1D4HB38N16F156006 is no longer needed for County purposes; and

**WHEREAS**, the Township of Elsinboro has expressed an interest in owning the vehicle for use in the Township; and

**WHEREAS**, the Salem County Administrator and Executive Director of the Office of Emergency Management recommend the donation of the said vehicle; and

**WHEREAS**, N.J. S.A. 40A:12-21.1 permits the sale of County property to a public entity without compliance with any other law governing disposal of personal property by Counties or Municipalities, for a consideration, which may be nominal; and

**WHEREAS**, N.J. S.A. 40A:12-21.1 stipulates that the property being transferred shall be used only for the purposes of that organization or association, and to render those services or to provide those facilities as may be agreed upon, and not for commercial business, trade or manufacture, and that if the personal property is not used in accordance with that limitation, ownership thereto shall revert to the county or municipality.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Salem that:

1. The County donates a 2006 Dodge Durango, bearing the vehicle identification number 1D4HB38N16F156006 in return for the payment of One Dollar (\$1.00).
2. The County Purchasing Agent is authorized to execute any and all documents necessary to effectuate the donation/sale of said vehicle, including the transfer the NJ Department of Motor Vehicles Title.
