**RESOLUTION APPROVING THE EXECUTION OF
CHANGE ORDER #3
CENTERTON TRAFFIC SIGNAL IMPROVEMENTS
ALMOND ROAD, COUNTY ROAD #540 AND
CENTERTON ROAD, COUNTY ROAD #553
IN PITTSBORO TOWNSHIP FOR THE COUNTY OF SALEM
FEDERAL PROJECT NO. CMAQ-0553(353)
NJDOT JOB NO. 7110317**

WHEREAS, the County of Salem issued a Contract in the amount of \$123,559.21 to "Diehl Electric, Inc." of Hammonton, New Jersey for the "CENTERTON TRAFFIC SIGNAL IMPROVEMENTS ALMOND ROAD, COUNTY ROAD #540 AND CENTERTON ROAD, COUNTY ROAD #553 IN PITTSBORO TOWNSHIP FOR THE COUNTY OF SALEM, FEDERAL PROJECT NO. CMAQ-0553(343), NJDOT JOB NO. 7110317" on July 17, 2019 per Resolution #2019-264; and

WHEREAS, the Salem County Board of Chosen Freeholders adopted Resolution #2020-072 on February 5, 2020 authorizing Change Order #1 to said contract for an additional cost of \$14,899.27; and

WHEREAS, the Salem County Board of Chosen Freeholders adopted Resolution #2020-131 on April 15, 2020 authorizing Change Order #2 to said contract for an additional cost of \$3,073.33; and

WHEREAS, N.J.A.C. 5:34-4.4(A) 3 requires that all change orders for capital projects be approved by the Board of Chosen Freeholders; and

WHEREAS, the County Engineer and Administrator recommend the approval of CHANGE ORDER #3 as described on the attached New Jersey Department of Transportation Federal Aid Change Order #3 form and the County of Salem Change Order Form #3 for a PROJECT DECREASE of ONE THOUSAND, SEVEN HUNDRED, EIGHTY-NINE DOLLARS AND FORTY-ONE CENTS (\$1,789.41) which in addition to Change Order #1 and Change Order #2 represents a 13.9% INCREASE in the Total Contract Cost resulting in a Total Contract Cost of \$139,742.40; and

WHEREAS, this Project is Funded through the NEW JERSEY DEPARTMENT OF TRANSPORTATION, FEDERAL AID PROGRAM; and

WHEREAS, the purpose of this Change Order #3 is to approve OVERAGE ITEMS and REDUCTION ITEMS, as more particularly described on the attached New Jersey Department of Transportation Federal Aid Program Change Order #3 Form.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of Chosen Freeholders that this CHANGE ORDER #3 be and is hereby approved for execution for the "CENTERTON TRAFFIC SIGNAL IMPROVEMENTS ALMOND ROAD, COUNTY ROAD #540 AND CENTERTON ROAD, COUNTY ROAD #553 IN PITTSBORO TOWNSHIP FOR THE COUNTY OF SALEM, FEDERAL PROJECT NO. CMAQ-0553(343), NJDOT JOB NO. 7110317; and

BE IT FURTHER RESOLVED that the Freeholder-Director and the Clerk of this Board of Chosen Freeholders be authorized to execute said NJDOT FEDERAL AID CHANGE ORDER #3 Form and Salem County Change Order Form #3.
