**RESOLUTION APPROVING CHANGE ORDER #2
FOR MIDATLANTIC STATES CAREER & EDUCATION CENTER**

WHEREAS, the Board of Chosen Freeholders of the County of Salem through the Office on Aging & Disabilities has an agreement with MidAtlantic States Career & Education Center to provide Meal services to senior Salem County residents which was adopted at the September 18, 2019 Freeholder meeting on Resolution 2019-364; and

WHEREAS, N.J.A.C. 5:34-4.49a03 requires that all change orders for services be approved by the Board of Chosen Freeholders; and

WHEREAS, there was an increase in Federal funding budget for Meal services for MidAtlantic States Career and Education Center services for 2020 and Office On Aging & Disabilities wishes to increase by the amount of \$3,000.00 (Three Thousand Dollars and Zero Cents); and


WHEREAS, the Salem County Purchasing Agent recommends the approval of Change Order #2 in the amount of Three Thousand Dollars and Zero Cents (\$3,000.00) increasing the contract to a total amount of Fifty Thousand, Five Hundred Dollars and Zero Cents (\$50,500.00); and

WHEREAS, all other terms of the original contract shall remain in force; and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2020 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem as follows:

1. The Board of Chosen Freeholders approves the issue of Change Order #2 authorizing MidAtlantic States Career and Education Center to increase funds encumbered by the County of Salem in the amount of \$3,000.00 for a total contract amount of \$50,500.00.
2. The Salem County Treasurer shall certify to the Board of Chosen Freeholders that the funds are available for payment of the increased amount as necessitated by the issuance of Change Order #2.
3. The Freeholder Director and the Clerk of the Board shall be authorized to execute said Change Order #2.


