**RESOLUTION AUTHORIZING ACCEPTANCE AND EXECUTION OF
NEW JERSEY DEPARTMENT OF TRANSPORTATION
FEDERAL HIGHWAY ADMINISTRATION
FEDERAL AID AGREEMENT NO. 20-DT-BLA-812
FOR THE DESIGN OF SOUTH GREENWICH STREET/TELEGRAPH ROAD,
COUNTY ROAD #540, PHASE 1, IN ALLOWAY TOWNSHIP
FOR THE COUNTY OF SALEM
FEDERAL PROJECT NO. STBGP-0540(300), NJDOT JOB NO. 7101316**

WHEREAS, the New Jersey Department of Transportation, Federal Highway Administration has made Funds available under the "Highway Planning and Construction 20.205 Program" for the Design and Construction of Road and Bridge Projects; and

WHEREAS, the County of Salem has determined that the "Design of South Greenwich Street/Telegraph Road, County Road #540, Phase 1 (from M.P. 13.15 to M.P. 15.40) does meet the criteria established for Funding and is known as NEW JERSEY DEPARTMENT OF TRANSPORTATION, FEDERAL AID AGREEMENT NO. 20-DT-BLA-812, FEDERAL PROJECT NO. STBGP-0540(300), and NJDOT JOB NO. 7101316; and

WHEREAS, the DESIGN of this Road was recommended by the County Engineer due to the deteriorating condition of the road; and

WHEREAS, the New Jersey Department of Transportation has informed the County of Salem that a Federal Highway Administration, Highway Planning and Construction 20.205 Program Grant for \$150,000.00 has been Authorized for this DESIGN Project.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of Chosen Freeholders as follows:

1. The NEW JERSEY DEPARTMENT OF TRANSPORTATION, FEDERAL HIGHWAY ADMINISTRATION, FEDERAL AID AGREEMENT NO. 20-DT-BLA-812 between the New Jersey Department of Transportation and the County of Salem is hereby approved.
2. The Freeholder-Director and the Clerk of the Board of Chosen Freeholders are authorized to sign the FEDERAL AID AGREEMENT.
3. Authorization is given to the New Jersey Department of Transportation as requested.
