RESOLUTION AUTHORIZING THE APPLICATION TO AND ACCEPTING FUNDING FOR THE 2020 CARES ACT GRANT FOR SALEM COUNTY BOARD OF ELECTIONS AND COUNTY CLERK

WHEREAS, the Governor of New Jersey issued Executive Order No.103 on March 9, 2020 declaring a Public Health Emergency and State of Emergency in response to the Coronavirus disease 2019 (COVID-19); and

WHEREAS, further actions by the Governor or New Jersey and the COVID-19 Task Force have resulted in the reduction of funding to certain programs throughout the State in order to re-allocate those resources towards the Public Health Emergency; and

WHEREAS, the County of Salem has received notice from the NJ Division of Elections that certain goods and services associated with the 2020 Primary Election of July 7, 2020 are eligible for reimbursement through the 2020 CARES Act Grant;

NOW THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that the Salem County Board of Elections and Salem County Clerk are authorized to submit an application to request funding for the 2020 CARES Act Grant for reimbursement of said costs associated with the Primary Election and hereby authorizes the Chief Financial Officer to accept the Grant.
