RESOLUTION AUTHORIZING THE TRADE-IN OF THREE EVINRUDE MODEL E55 MRLAF OUTBOARD MOTORS FOR ONE 9.9 EH 4STROKE OUTBOARD MOTOR INCLUDING GAS TANK, FUEL HOSES, AND KIT TO RETROFIT TO BOAT

WHEREAS, the County of Salem (County) is a body politic and corporate of the State of New Jersey with main offices located at 94 Market Street, Salem, New Jersey 08079; and

WHEREAS, the County of Salem has determined that three (3) Evinrude Model E55 MRLAF outboard motors, bearing the serial numbers, 05431048, 05431051 and 05431052 can't be used for County purposes as expected on the Zodiac boat; and

WHEREAS, these three motors are declared surplus and would otherwise be included in the next County auction; and

WHEREAS, South Jersey Boatworks, located at 401 Orange St. Millville, NJ 08332 will accept the trade-in of three engines, crediting the County for \$1,020.00 each, which totals \$3,060.00; and

WHEREAS, the County of Salem Sheriffs Office of Emergency Management wishes to purchase one new 9.9EH 4 stroke outboard motor, including gas tank, fuel hoses, and retrofit kit, which will fit on the Zodiac Boat, at cost of \$3,060.00 which is an equal trade; and

WHEREAS, the Salem County Administrator and Executive Director of the Office of Emergency Management recommend the trade-in of the 3 said boat engines in exchange for the purchase of one new 9.9EH 4 stroke outboard motor, including gas tank, fuel hoses, and retrofit kit; and

NOW THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Salem that

1. The County declares the three (3) Evinrude Model E55 MRLAF outboard motors, bearing the serial numbers, 05431048, 05431051 and 05431052 surplus; and
2. The County will accept an equal exchange for the three Evinrude Model E55 MRLAF Outboard motors for one new 9.9EH 4 stroke outboard motor including gas tank, fuel hoses, and retrofit kit.
