**RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION TO NJ TRANSIT CORPORATION ON BEHALF OF SALEM COUNTY OFFICE ON AGING AND DISABILITIES FOR A GRANT UNDER THE SENIOR CITIZEN AND DISABLED RESIDENT TRANSPORTATION ASSISTANCE ACT (SCDRTAP) GRANT 2021**

**WHEREAS**, in 1984 the governor of New Jersey signed into law legislation creating the Senior Citizen and Disabled Resident Transportation Assistance Act (SCDRTAP); and

**WHEREAS**, under this law Casino Tax Revenues may be utilized for the provision of elderly (60+) and disabled transportation; and


**WHEREAS**, the County of Salem must submit an application to NJ Transit Corporation to obtain funding in the amount of \$421,664.00 (Four Hundred Twenty One Thousand Six Hundred Sixty Four Dollars and Zero Cents), with no match required, for the period covering January 1, 2021 to December 31, 2021; and

**WHEREAS**, the County of Salem will provide transportation services as described and intended by the Senior Citizen and Disabled Resident Transportation Assistance Act (SCDRTAP); and


**WHEREAS**, Stephanie Bradway, Transportation Program Coordinator, shall forward one (1) original application together with one (1) certified copy of this resolution to:
