RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION FOR STATE AID TO COUNTIES UNDER THE NEW JERSEY DEPARTMENT OF TRANSPORTATION LOCAL BRIDGES FUND PROGRAM FOR FISCAL YEAR 2021

WHEREAS, the NEW JERSEY DEPARTMENT OF TRANSPORTATION has made available a minimum of \$1,256,041.00 for construction and/or reconstruction of BRIDGES under the NEW JERSEY DEPARTMENT OF TRANSPORTATION, TRANSPORTATION TRUST FUND for FISCAL YEAR 2021; and

WHEREAS, the County has determined that the project, more particularly described in the GRANT APPLICATION for the FISCAL YEAR 2021 LOCAL BRIDGES FUND as the REPLACEMENT OF AVIS MILL BRIDGE, COUNTY BRIDGE #1704-139 ON AVIS MILL ROAD, A LOCAL ROAD, OVER SALEM CREEK IN PILESGROVE TOWNSHIP, which is classified as "Functionally Obsolete"; and

WHEREAS, no "Matching Funds" are required under the aforementioned LOCAL BRIDGES FUND PROGRAM; and

NOW, THEREFORE, BE IT RESOLVED the Salem County Board of County Commissioners formally approve the GRANT APPLICATION for the above stated Project.

BE IT FURTHER RESOLVED that the Director of the Board of County Commissioners and the Clerk of the Board hereby authorize the County Engineer to submit an electronic Grant Application identified as LBFN-2021-Replacement of Avis Mill Bridge-00042 to the New Jersey Department of Transportation on behalf of the County of Salem.

BE IT FURTHER RESOLVED that the Director of the Board of County Commissioners and the Clerk of Board are hereby authorized to sign the Grant Agreement, when received from the New Jersey Department of Transportation, on behalf of the County of Salem and that their signatures constitute acceptance of the "Terms and Conditions" of the Grant Agreement and therefore approve the execution of the Grant Agreement.
