**RESOLUTION APPROVING THE EXECUTION OF  
CHANGE ORDER #2  
FY 2018 RAILROAD REHABILITATION PROGRAM  
FOR THE COUNTY OF SALEM  
NJDOT RAIL FREIGHT ASSISTANCE PROGRAM  
GRANT #7112310**

**WHEREAS,** the County of Salem issued a Contract in the amount of \$6,184,032.00 to "Railroad Construction SJ, Inc." of Paulsboro, New Jersey for the "FY 2018 RAILROAD REHABILITATION PROGRAM FOR THE COUNTY OF SALEM, NJDOT RAIL FREIGHT ASSISTANCE PROGRAM, GRANT #7112310" on November 20, 2019 per Resolution #2019-437; and

**WHEREAS,** the County of Salem adopted Resolution #2020-159 on May 6, 2020 authorizing Change Order #1 to said contract for an additional cost of \$187,529.70; and

**WHEREAS,** N.J.A.C. 5:34-4.4(A) 3 requires that all change orders for capital projects be approved by the Board of County Commissioners; and

**WHEREAS,** the County Engineer and Administrator recommend the approval of CHANGE ORDER #2 as described on the attached New Jersey Department of Transportation Federal Aid Change Order #2 form and the County of Salem Change Order Form #2 for a PROJECT DECREASE of THREE HUNDRED, SEVENTEEN THOUSAND, SIXTY-SEVEN DOLLARS AND FORTY-NINE CENTS (-\$317,067.49) which in addition to Change Order #1 represents a 2.8% DECREASE in the Total Contract Cost resulting in a Total Contract Cost of \$6,054,494.21; and


**WHEREAS,** this Project is Funded 90% through the NEW JERSEY DEPARTMENT OF TRANSPORTATION, FEDERAL AID PROGRAM and 10% by the COUNTY OF SALEM; and

**WHEREAS,** the purpose of this Change Order #2 is to approve EXTRA Work Items and two (2) Supplemental Work Items and Reduction Items, as more particularly described on the attached New Jersey Department of Transportation Federal Aid Change Order #2 Form.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that this CHANGE ORDER #2 be and is hereby approved for execution for

the "FY 2018 RAILROAD REHABILITATION PROGRAM FOR THE COUNTY OF SALEM, NJDOT RAIL FREIGHT ASSISTANCE PROGRAM, GRANT #7112310"; and

**BE IT FURTHER RESOLVED** that the Director and the Clerk of this Board of County Commissioners be authorized to execute said NJDOT FEDERAL AID CHANGE ORDER #2 Form and Salem County Change Order Form #2.
