**RESOLUTION ADOPTING THE 2021 TEMPORARY BUDGET**

**WHEREAS**, the Board of County Commissioners of the County of Salem desires to make temporary appropriations to cover the period between the beginning of the budget year and the adoption of its regular budget, and

**WHEREAS**, 26.25% of the total operating appropriations in the 2020 budget exclusive of any appropriations made for Debt Service, Capital Improvement, and Social Services was the sum of \$21,584,012.37; and

**WHEREAS**, the attached appropriations total less than 26.25% of the total appropriations made in the preceding fiscal year, and

**NOW, THEREFORE BE IT RESOLVED** that the following temporary appropriations be made for the year 2021:
