**RESOLUTION APPROVING THE EXECUTION OF
CHANGE ORDER #1-FINAL
EMERGENCY ROAD AND BRIDGE REPAIRS
THROUGHOUT THE COUNTY OF SALEM
FOLLOWING THE AUGUST 7TH, 2020 UNUSUAL STORM EVENT
FOR THE COUNTY OF SALEM**

WHEREAS, the County of Salem issued a Contract in the amount of \$289,329.50 to "Richard E. Pierson Construction Co., Inc." of Woodstown, New Jersey for the EMERGENCY ROAD AND BRIDGE REPAIRS THROUGHOUT THE COUNTY OF SALEM FOLLOWING THE AUGUST 7TH, 2020 UNUSUAL STORM EVENT FOR THE COUNTY OF SALEM on September 2, 2020 per Resolution #2020-296; and

WHEREAS, the County Engineer and Administrator recommend the approval of CHANGE ORDER #1-FINAL as more particularly described on the attached Salem County Change Order Form #1-FINAL, for a PROJECT DECREASE of SEVENTY-EIGHT THOUSAND, FOUR HUNDRED, SIXTY-ONE DOLLARS AND EIGHTY-EIGHT CENTS (\$78,461.88), which represents a 27% DECREASE in the Total Contract Cost; and

WHEREAS, the purpose of this Change Order #1-FINAL is to approve Reduction Items, as more particularly described on the attached Salem County Change Order Form #1-FINAL; and

WHEREAS, N.J.A.C. 5:34-4.4(A) 3 requires that all change orders for capital projects be approved by the Board of County Commissioners; and

WHEREAS, this Project is Funded through the COUNTY OF SALEM.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that this CHANGE ORDER #1-FINAL be and is hereby approved for execution for the EMERGENCY ROAD AND BRIDGE REPAIRS THROUGHOUT THE COUNTY OF SALEM FOLLOWING THE AUGUST 7TH, 2020 UNUSUAL STORM EVENT FOR THE COUNTY OF SALEM; and

BE IT FURTHER RESOLVED that the Director and the Clerk of this Board of County Commissioners be authorized to execute said Salem County Change Order Form #1-FINAL.
