**RESOLUTION APPOINTING A CERTIFIED COUNTY FINANCE OFFICER FOR THE COUNTY OF SALEM**

**WHEREAS**, in June 2018 the County’s Chief Financial Officer tendered written resignation effective June 30, 2018; and

**WHEREAS**, N.J.S.A. 40A:9-28.4(d) permits the appointment of a non-certified Chief Financial Officer for a period not to exceed one year, and which may be extended for an additional year with approval of the Director of the Division of Local Government Services; and

**WHEREAS**, Resolution 2018-272 appointed Kelly A. Hannigan Temporary Chief Financial Officer effective August 15, 2018; and

**WHEREAS**, Resolution 2019-280 appointed Kelly A. Hannigan Temporary Chief Financial Officer for an additional year, approved by the Director of the Division of Local Government Services and effective August 15, 2019; and

**WHEREAS**, the Covid-19 pandemic resulted in the cancellation of the exam for CFO and the Governor of New Jersey signed legislation, PL 2020 Chapter 34, section 3 C.52:27D-18.7, extending the appointment of temporary chief financial officer renewal for an additional year, and Resolution 2020-203 appointed Kelly A. Hannigan Temporary Chief Financial Officer for an additional year, approved by the Director of the Division of Local Government Services and effective July 1, 2020; and

**WHEREAS**, Kelly A. Hannigan has completed all courses required and passed the State examination administered on December 2, 2020 for Certified Municipal Finance Officer with notification of passing grades received on January 29, 2021, in addition to completing and passing the County Fiscal Operations course on October 31, 2020 for Certified County Finance Officer.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Salem, that Kelly A. Hannigan is hereby appointed to a three-year term as the Certified County Finance Officer for the County of Salem effective January 1, 2021.
