RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS ACCEPTING AND EXECUTING AND ACCEPTING GRANT SCP-21-PS-17, SCP-21-PM-17, FC-21-17 FOR THE COUNTY OF SALEM YOUTH SERVICES COMMISSION FROM THE NEW JERSEY JUVENILE JUSTICE COMMISSION

WHEREAS, the Board of County Commissioners ("Board") recognizes a continuing need to assist the Salem County Youth Service Commission ("SCYSC") in efforts to provide various approved Juvenile Justice programming for at-risk youth and or adjudicated delinquent youth; and

WHEREAS, the SCYSC has approved the 2021 Youth Services Comprehensive Plan and award notice to be signed by the Salem County Board of County Commissioners received from the New Jersey Juvenile Justice Commission ("JJC") authorizing the consolidation, planning, implementation, monitoring and evaluation of community based services for juveniles charged or adjudged as delinquent and delinquency prevention programs by the Salem County Youth Services Commission in accordance with regulations outlined in the JJC grant acceptance letter, certified assurances, N.J.A.C. 13:90 Law and Public Safety, and grant conditions on file with the Clerk of the Board; and

WHEREAS, the Board recognizes the grant reimbursement is for a one year period from January 1, 2021 to December 31, 2021 with total funding of \$301,227.00.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

1. The project grant on file with the Clerk of the Board is approved and accepted.
2. The Deputy Director of Operations, the Chief Financial Officer, the Salem County Youth Services Coordinator from the Salem Inter Agency Council of Human Services Inc. as well as any other necessary parties, are hereby authorized and directed to execute all project grant documents provided by the Juvenile Justice Commission.
3. Three (3) fully executed copies of this resolution shall be provided to the Salem County Inter Agency Council of Human Services.
