**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS
SUPPORTING AND APPROVING A U. S. DEPARTMENT OF JUSTICE, BUREAU
OF JUSTICE ASSISTANCE (BJA) SMART PROSECUTION – INNOVATIVE
PROSECUTION SOLUTIONS GRANT FOR FY21 FOR THE PROSECUTOR'S
OFFICE**

WHEREAS, the Board of County Commissioners ("Board") recognizes a continuing need to assist the Prosecutor's Office by assisting prosecutors to develop effective strategies to combat and prosecute violent crime; and

WHEREAS, the U.S. Department of Justice, Bureau of Justice Assistance is offering the Prosecutor's Office participation in a Smart Prosecution – Innovative Prosecution Solutions Grant to assist prosecutors to develop effective strategies to combat and prosecute violent crime in accordance with the Program Grant Application on File with the Clerk of the Board; and

WHEREAS, the application will result in a Grant to the Salem County Prosecutor's Office appropriated under the U.S. Department of Justice, Bureau of Justice Assistance (BJA) Smart Prosecution – Innovative Prosecution Solutions Grant for the period of October 1, 2021 through September 30, 2023, in an amount yet to be determined by the U.S. Department of Justice, Bureau of Justice Assistance but not to exceed Three Hundred Forty Thousand Dollars (\$340,000.00); and

WHEREAS, this agreement shall further be contingent upon availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget; and

WHEREAS, the Board supports this grant application.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem that:

1. The program grant outlined in the Program Grant Application filed on-line in accordance with notification received from the U.S. Department of Justice, Bureau of Justice Assistance is supported and approved by the Public Safety Committee.
2. The County Prosecutor, the Chief Finance Officer, the Project Contact person from the Prosecutor's Office, as well as any other necessary parties, are hereby authorized and directed to execute all project grant documents provided by the Division.
3. Five fully executed copies of this resolution shall be provided to the County Prosecutor forthwith.
