**RESOLUTION APPROVING THE EXECUTION OF
CHANGE ORDER #2-FINAL
2014 COUNTY AID ROAD PROGRAM, PHASE 1
FOR THE COUNTY OF SALEM**

WHEREAS, the County of Salem issued a Contract in the amount of \$1,219,818.92 to "South State, Inc." of Bridgeton, New Jersey for the 2014 COUNTY AID ROAD PROGRAM, PHASE 1 FOR THE COUNTY OF SALEM on September 6, 2017 per Resolution #2017-267; and

WHEREAS, the County of Salem approved Change Order #1 in the amount of \$70,33.80 for the 2014 COUNTY AID ROAD PROGRAM, PHASE 1 FOR THE COUNTY OF SALEM on May 1, 2021, per Resolution #2019-185; and

WHEREAS, the County Engineer and Administrator recommend the approval of CHANGE ORDER #2-FINAL as described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2-FINAL and the County of Salem Change Order Form #2-FINAL for a PROJECT INCREASE of FORTY-EIGHT THOUSAND, ONE HUNDRED, SEVENTY-NINE DOLLARS AND TWENTY-SEVEN CENTS (\$48,179.27) which, in addition to Change Order #1, represents a .0973% INCREASE in the Total Contract Cost, resulting in a Total Contract Cost of \$1,338,531.99; and

WHEREAS, this Project is Funded through the NEW JERSEY DEPARTMENT OF TRANSPORTATION, COUNTY AID IMPROVEMENT PROGRAM; and

WHEREAS, the purpose of this Change Order #2-FINAL is to approve OVERAGE and REDUCTION items as more particularly described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2-FINAL Form.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that this CHANGE ORDER #2-FINAL be and is hereby approved for execution for the 2014 COUNTY AID ROAD PROGRAM, PHASE 1 FOR THE COUNTY OF SALEM; and

BE IT FURTHER RESOLVED that the Director and the Clerk of this Board of County Commissioners be authorized to execute said NJDOT LOCAL AID PROJECTS CHANGE ORDER #2-FINAL Form and Salem County Change Order Form #2-FINAL.
