RESOLUTION AUTHORIZING THE EXECUTION OF THE STATE COMMUNITY PARTNERSHIP GRANT FOR THE SALEM COUNTY INTER-AGENCY COUNCIL 2021 YOUTH SERVICES COMMISSION

WHEREAS, the original resolution was tabled at the March 17, 2021 meeting; and

WHEREAS, the Juvenile Justice Commission (JJC) has allocated the following funding to the County of Salem Youth Services Commission:

State/Community Partnership – 1/1/2021 – 12/31/2021	
Program Services Funds	\$145,416.00
Program Management Funds	\$ 55,550.00
Family Court Services – 1/1/2021 – 12/31/2021	\$100,231.00
Comprehensive Funding Grand Total	\$301,227.00; and

WHEREAS, the Salem County Youth Services Commission has recommended allocation of these funds based on Request for Proposals that were distributed throughout the County; and

WHEREAS, the Salem County Board of Chosen Commissioners agrees with these recommendations and authorizes Salem County Inter-Agency Council to enter into agreements for the following services.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that the County of Salem allocate the JJC Partnership and Family Court funding as follows:

\$1,500	Client Specific Funds for IAC General Funds	Managed by Salem County Inter Agency

\$25,000	Client Specific Funds for Substance Use Treatment	Managed by Salem County Inter Agency
\$55,550	Salem Inter-Agency Council	Program Management Funds
\$40,000	Salem County Department of Corrections	Juvenile GPS Ankle Bracelet Monitoring
