RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION TO NJ TRANSIT CORPORATION ON BEHALF OF SALEM COUNTY OFFICE ON AGING AND DISABILITIES FOR A GRANT UNDER THE SENIOR CITIZEN AND DISABLED RESIDENT TRANSPORTATION ASSISTANCE ACT (SCDRTAP) GRANT 2022

WHEREAS, in 1984 the Governor of New Jersey signed into law legislation creating the Senior Citizen and Disabled Resident Transportation Assistance Act (SCDRTAP); and

WHEREAS, under this law Casino Tax Revenues may be utilized for the provision of elderly (60+) and disabled transportation; and

WHEREAS, the County of Salem must submit an application to NJ Transit Corporation to obtain funding in the amount of \$414,649.00, with no match required, for the period covering January 1, 2022 to December 31, 2022; and

WHEREAS, the County of Salem will provide transportation services as described and intended by the Senior Citizen and Disabled Resident Transportation Assistance Act (SCDRTAP); and

WHEREAS, Stephanie Bradway, Transportation Program Coordinator, shall forward one (1) original application together with one (1) certified copy of this resolution to:
