**RESOLUTION APPROVING THE EXECUTION OF
CHANGE ORDER #2
2018 COUNTY AID ROAD PROGRAM
FOR THE COUNTY OF SALEM**

WHEREAS, the County of Salem issued a Contract in the amount of \$2,493,050.60 to "Richard E. Pierson Construction Company, Inc." of Woodstown, New Jersey for the 2018 COUNTY AID ROAD PROGRAM FOR THE COUNTY OF SALEM on November 4, 2020 per Resolution #2020-274; and

WHEREAS, the County of Salem adopted Resolution #2021-056 on January 20, 2021 authorizing Change Order #1 to said contract for a reduction in cost of -\$7,020.00; and

WHEREAS, the County Engineer and Administrator recommend the approval of CHANGE ORDER #2 as more particularly described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2 and Salem County Change Order Form #2, for a PROJECT INCREASE of FIFTY-SEVEN THOUSAND, SIX HUNDRED, FIVE DOLLARS AND ZERO CENTS (\$57,605.00), which in addition to Change Order #1 represents a 2.04% INCREASE in the Total Contract Cost; and

WHEREAS, the purpose of this Change Order #2 is to approve two (2) Supplemental Items, as more particularly described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2 Form and the Salem County Change Order Form #2; and

WHEREAS, N.J.A.C. 5:34-4.4(A) 3 requires that all change orders for capital projects be approved by the Board of County Commissioners; and

WHEREAS, this Project is Funded through the NEW JERSEY DEPARTMENT OF TRANSPORTATION, COUNTY AID PROGRAM.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that this CHANGE ORDER #2 be and is hereby approved for execution for the 2018 COUNTY AID ROAD PROGRAM FOR THE COUNTY OF SALEM; and

BE IT FURTHER RESOLVED that the Director and the Clerk of this Board of County Commissioners be authorized to execute said NJDOT LOCAL AID PROJECTS CHANGE ORDER #2 Form and Salem County Change Order Form #2.


