**RESOLUTION APPROVING CHANGE ORDER #8
FOR MID-ATLANTIC STATES CAREER AND EDUCATION CENTER**

WHEREAS, the Salem County Board of County Commissioners through the Office on Aging & Disabilities has an agreement with Mid-Atlantic States Career and Education Center to provide Congregate Services to senior Salem County residents which was adopted at the September 18, 2019 Freeholder meeting on Resolution 2019-364 in the amount of \$47,500.00; and

WHEREAS, N.J.A.C. 5:34-4.49a03 requires that all change orders for services be approved by the Salem County Board of County Commissioners; and

WHEREAS, N.J.A.C. 5:34-4.49a03 requires that all change orders which exceed 20% of the original contract amount for services be approved by the Salem County Board of County Commissioners; and

WHEREAS, there was a previous change order in the amount of \$46,000.00 for Congregate services for 2021 by Office On Aging & Disabilities under Resolution 2021-100; and

WHEREAS, Office On Aging & Disabilities wishes to additionally increase with Change Order #8 by the amount of \$49,000.00 (Forty Nine Thousand Dollars and Zero Cents) for Congregate services for 2021; and

WHEREAS, the Salem County Purchasing Agent recommends the approval of Change Order #8 in the amount of \$49,000.00 (Forty Nine Thousand Dollars and Zero Cents) increasing the contract to a total amount of \$142,500.00 (One Hundred Forty Two Thousand Five Hundred Dollars and Zero Cents). This increase exceeds the 20% regulation; and


WHEREAS, all other terms of the original contract shall remain in force; and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2021 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County's temporary and/or permanent budget.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. The Salem County Board of County Commissioners approves the issue of Change Order #8 authorizing Mid-Atlantic States Career and Education Center to increase funds encumbered by the County of Salem in the amount of \$49,000.00 for a total contract amount of \$142,500.00.
2. The Salem County Treasurer shall certify to the Salem County Board of County Commissioners that the funds are available for payment of the increased amount as necessitated by the issuance of Change Order #8.

3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said Change Order #8.


