RESOLUTION AWARDING CONTRACT FOR FURNISHING AND DELIVERING ROCK SALT FOR THE COUNTY OF SALEM AND THE MEMBERS OF THE SALEM COUNTY COOPERATIVE PRICING SYSTEM IDENTIFIER NUMBER 75-SCCP

WHEREAS, The Salem County Purchasing Agent, as authorized contracting Agent for the Board of County Commissioners for the County of Salem, has requested, received and opened sealed bids on August 13, 2021 11:00am prevailing time for Furnishing and Delivering Rock Salt for the County of Salem and Members of the Salem County Cooperative Pricing System (#75-SCCP). The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, bids were received from five (5) bidders as follows:

WHEREAS, It has been determined that the company of **Riverside Construction Materials (Silvi Group Companies)** has substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; and

WHEREAS, the period of this contract will commence on September 1, 2021 and will terminate August 31, 2022, with two (2) additional one (1) year renewal options.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

The Board of County Commissioners of the County of Salem hereby awards a contract for Furnishing and Delivering Rock Salt for the County of Salem, subject to the review of the County Solicitor, to **Riverside Construction Materials (Silvi Group Companies), 355 Newbold Road, Fairless Hills, PA 19030.**

1. For the purpose of Furnishing and Delivering Rock Salt for the County of Salem and the members of the Salem County Cooperative Pricing System Identifier Number 75-SCCP. Cost per ton shall not exceed \$62.50 (Sixty-Two Dollars and Fifty Cents) and total cost

over the term of the first year contract shall not exceed \$500,000.00 (Five Hundred Thousand Dollars and Zero Cents) with the cost of CY 2021 not to exceed \$80,000.

2. The contract commences September 1, 2021 and will terminate August 31, 2022, with two (2) additional one (1) year renewal options. This shall be completed in full accordance with the terms and conditions of the contract.

3. The Board of County Commissioners Deputy Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


